

Terms and Conditions

Please read the following terms and conditions very carefully as your use of service is subject to your acceptance of and compliance with the following terms and conditions ("Terms").

By subscribing to or using any of our services you agree that you have read, understood and are bound by the Terms, regardless of how you subscribe to or use the services. If you do not want to be bound by the Terms, you must not subscribe to or use our services.

In these Terms, references to "you", "User" shall mean the end user accessing the Website, its contents and using the Services offered through the Website. "Service Providers" mean independent third party service providers, and "we", "us" and "our" shall mean A.A.I. Online (Owner company of shybuy.lk), its franchisor, affiliates and partners.

- 1. www.shybuy.lk website ("Website") is an Internet based content and e-commerce portal operated by A.A.I Online, a company incorporated under the laws of Sri Lanka.
- 2. Use of the Website is offered to you conditioned on acceptance without modification of all the terms, conditions and notices contained in these Terms, as may be posted on the Website from time to time. www.shybuy.lk at its sole discretion reserves the right not to accept a User from registering on the Website without assigning any reason thereof.

You will receive a password and account designation upon completing the Website's registration process. You are responsible for maintaining the confidentiality of the password and account, and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify shybuy.lk of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. shybuy.lk cannot and will not be liable for any loss or damage arising from your failure to comply with this Section 2.
